## **AMENDMENT TO PROTECTIVE COVENANTS**

NOW THEREFORE, pursuant to its authority and provision of the Bylaws for The Manor, A Planned Community, Inc., paragraph 6 of the original Declaration of Protective Covenants is amended by removing the current paragraph 6 and replacing therefore the following language: "All residences shall be a minimum of 4,000 square feet excluding garage, patio, breezeways, basements and porches."

In all other respects, the Declaration of Protective Covenants, as amended shall remain in full force and effect.
